The purpose of this modification is to 1) Exercise Option Year One effective March 16, 2010 thru March 15, 2011, and 2) Increase the contract ceiling by \$64,500.00.

1) This modification hereby Exercises Option Year One effective March 16, 2010 thru March 15, 2011. Accordingly, Section A.3 DURATION OF THE CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988), the first sentence is deleted in its entirety and replaced with the following:

“The ordering period for this contract shall commence on March 16, 2009 and will expire on March 15, 2011.”

2) This modification hereby increases the current contract ceiling by \$64,500.00 from \$61,500.00 to \$126,000.00. Accordingly, Section A.5 CONSIDERATION AND OBLIGATION – DELIVERY ORDERS, Part (a), the first sentence is deleted in its entirety and replaced with the following:
