SUBJECT: TERMINATION OF YOUR NRC RADIOACTIVE MATERIALS LICENSE

On letter dated August 12, 2009, you informed the U.S. Nuclear Regulatory Commission that you wished to terminate NRC License No. STB-1168 and provided decommissioning information to support the request to release the facility for unrestricted use. The NRC conducted a technical evaluation of your request and documented its findings in a Technical Evaluation Report dated June 10, 2010 (ADAMS accession number ML101610624). The results of the licensee's final status survey, as confirmed through NRC confirmatory and reciprocity inspections, indicate that the location authorized in License No. STB-1168 meets the radiological criteria for unrestricted use. Your facility located at Corpus Christi Army Depot, as authorized in NRC License No. STB-1168, is suitable for unrestricted use in accordance with 10 CFR 20.1402, "Radiological Criteria for Unrestricted Use." Therefore, NRC License No. STB-1168 is hereby terminated as stated in the enclosed Amendment No. 27 to the license. An environmental assessment for this licensing action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(20)(iii).
