In response to the letter of May 24, 2010, regarding documentation to support our assertion related to control area access of licensed material use and storage I would like to inform the following. The reception desk staffs were trained on the responsibility to control access of the radioactive area on November 16, 2009, before we start operation of the Nuclear Medicine Department at Rio Grande Nuclear.


The Nuclear Medicine Technologist, Jiselle Carrillo, oriented reception staff on how to control patient's access and do not allow any person to cross the door on the reception area. If they authorize someone to enter through that door, they have the responsibility to take them to the correct place. A sign on the reception door was posted to warning the patient to do not enter through the reception door without authorization.

All patients are escorted by Nuclear Medicine Technologist to the licensed material area of use when called for a nuclear medicine procedure. Furthermore, none personal staff at Rio Grande Nuclear have access to the licensed material area of storage at any time.

On November 16, 2010, the Nuclear Medicine Technologist and the reception desk staff were oriented of Radiation Safety by Nuclear Physics, David Rhoe. They read a module about it and signed it. Refer to attachment for attendance record of this Radiation Safety orientation.

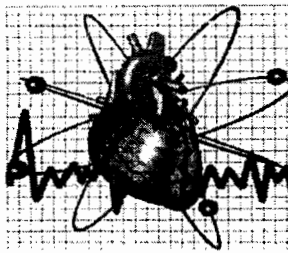
