In response to your email, see responses below.

1). NJ has about 503 NRC licenses and 491 qualified as small entities and received reduced fees? This number seems high - in the NRC FY2007 fee proposal it states that in FY 2006 31% of the licenses (1300) qualified as small entities.

For FY 2007 NJ had a total of 491 licensees. Of the 491 licensees, 166 qualified as small entities.

Can I get a listing of all the NJ NRC licenses and their respective fees for FY 2007?

2). I have a listing of NJ NRC licenses and fee categories. There are licenses that are listed as exempt from category 2B. Where is this exemption listed in the reg?

There is a notation listed under the appropriate fee categories noting that if source material is listed on the same license then 2B is exempt. Refer to notation for fee categories 7A, 7B, and 7C.

3). Has the NRC reconciled the program codes with the fee categories?

Yes, we have a Pilot Program effective January 4 - June 30, 2008, using the program codes/fee categories crosswalk.
