Here's the info:

At the current time, the NRC Office of Investigations has three pending investigations that may result in escalated enforcement actions against an NRC licensee located within the State. The NRC Office of Enforcement has one pending enforcement action against a licensee. Additionally, six allegations are currently open related to NRC licensees within the State. The remaining open actions that the NRC is unable to close between now and the effective date of the Agreement will either continue to be handled by the NRC with the involvement of the State or will be transferred to the State. The NRC will work closely with the State to ensure the smooth transition of authority over these open cases before the effective date of the Agreement.

Hi Donna - here are 2 paragraphs from the SECY I'll need to update.

Item 4 below is the "actions pending" paragraph. I haven't updated from Commonwealth to NJ - we'll need the open investigations, enforcement, allegations and such.

Item 5 below - I didn't know if we had any of these things. I need to update the information there re: the orders - you probably know more than I do - should I go to Kim and Ernesto for this information? Or is it already outdated material since there are license conditions? I'm not real knowledgeable on this stuff given it was all starting while I was in Rulemaking.

(4) Actions Pending against Licensees to be Transferred

(5) Outstanding Orders, Confirmatory Action Letters, and 10 CFR 2.206 Petitions against Licensees that Will Transfer
