Hello Pat,

I have reviewed the licenses for the said licensees. You are correct, the licenses are incorrectly classified under the broad scope program, code (02120) but, classified-correctly under the fee category 7C. Most of the program codes does not correspond with the licenses, as written. The NRC hope to correct this problem soon. We are in the process of crosswalking the program codes via the fee categories to correct the problem in our systems. Therefore, we do not depend upon the program codes to determine the fees.
