Corrected Information Addressing Existing Land Use in York County, South Carolina:

Duke Energy has identified the need to correct the existing land use information for York County, South Carolina, contained in the Lee Nuclear Station Combined License Application, Part 3 Environmental Report (ER), Table 2.2-2. The current revision of ER Table 2.2-2 is based on "York County, The County of York Comprehensive Plan: Charting the Course to 2025, Website, http://www.yorkcounty.gov/2020/general/adopted_comprehensive_plant.htm, accessed August 21, 2006." That reference is to York County, Virginia, rather than the intended location, York County, South Carolina. The correct reference is "York County, 2025 York County Comprehensive Plan, Website, http://www.yorkcountygov.com/Departments/DepartmentsNZ/ PlanningandDevelopment/ComprehensivePlan.aspx, accessed October 28, 2009."

Duke Energy Requested Revisions:

ER Table 2.2-2 will be revised to incorporate the York County, South Carolina data per the correct reference, 2025 York County Comprehensive Plan. As a result, ER Chapter 2 List of Tables, and Section 2.2.4 Reference 15, will be corrected.

Associated Lee Nuclear Station COL Application Revisions:

The following revisions will be made to the Lee Nuclear Station ER.

1. Replace COLA Part 3, ER Chapter 2, Table 2.2-2, with the following:
