Steve and Bill,

We have reviewed the questions in RAIs 162 and 167 (re seismic subsystems and category 1 structures). Of the 27 numbered questions in these two RAIs, we feel that about 19 seem to need additional discussion with the NRC. In maybe two or three cases we need some clarification but in most of the cases we need to discuss the bases of the questions and potential alternatives that we intend to pursue to respond to the questions. Some of these options involve resource intensive evaluations or calculations. We would like to confirm that our proposed approaches will provide the information that the NRC needs to write their SER before we expend these resources. Our goal is to issue responses that close all the issues associated with these questions.

Our recommendation is that we schedule a public conference call to discuss these questions. The CPNPP COLA team can be prepared to support such a call by the week of June 21, 2010; therefore, I hereby request a public conference call to discuss the questions in RAIs 162 and 167 during the week of June 21, 2010. This may be a lengthy call because these are complex topics. I suggest Tuesday, June 22, 2010, but any day that week should work. Please determine if the NRC staff and its reviewers can support such a call and propose a date and time.

Due to the need for this public conference call, I am also requesting an extension to respond to these RAIs. I suggest a 32 day extension which would make the new due date Monday, July 26, 2010.
