Pursuant to 10 C.F.R. § 2.336(d) and the Board's June 3, 2010 Order granting the NRC Staff an extension of time, the Staff herein provides notice that it has revised its Initial Disclosure, Supplemental Disclosure 1, and Supplemental Disclosure 11 for this proceeding. The Staff has produced an amended Initial Disclosure containing: 1) an updated index of each item that was not previously disclosed in that hearing file and 2) an updated sensitive information log containing files that were not previously documented as being withheld. The Staff has produced an amended Supplemental Disclosure 1 containing: 1) updated index of each item that was not previously disclosed in that hearing file and 2) a corrected deliberative process privilege log as required by 10 C.F.R. § 2.336(b)(5). The Staff has produced an amended Supplemental Disclosure 11 containing an updated index of each item that was not previously disclosed in that hearing file. The Staff is continuing to preserve and maintain required privileged documents during the pendency of this proceeding.
