SUBJECT: PROCESS TO ISSUE THE REPORT TO CONGRESS ON ABNORMAL  
OCCURRENCES (NUREG-0090, VOLUME 32)

The Office of Nuclear Regulatory Research staff has obtained Commission approval in the Staff Requirements Memorandum dated May 6, 2010 on SECY-10-0024 "Report to Congress on Abnormal Occurrences: Fiscal Year 2009," to publish the abnormal occurrence report to Congress.

Enclosed for final processing is a *Federal Register* notice (FRN) announcing publication of the Abnormal Occurrence Report for Fiscal Year 2009 (Enclosure 1) and the letters to Congress for Chairman Jaczko's signature forwarding the printed report to Congress (Enclosure 2).
