Hi again all -

Attached is the Advisory PAPO's Memo in response to the joint motion from NV counties on Webstreaming of ASLB proceedings. In short, the Advisory PAPO indicated that it is a solely an advisory body and thus does not have authority to grant or deny the counties' motion to implement Webstreaming. The memo also advises that the Commission authorized NRC staff to implement a Webstreaming pilot project (6 feeds). Due to delays in procuring a contract, the ASLB projects that the earliest date a contract could be awarded is sometime this summer, and that the earliest date a contract could be implemented is later still.

As an aside, my understanding is that NRC is continuing to work with Cox Communications to see what may be possible for Webstreaming (Cox worked with us to Webcast the first PAPO board proceeding last year). I'll keep you posted.
