- Web streaming of Yucca Mountain licensing hearings for public/AULG access.
- Future of NRC's Las Vegas facility (we have heard concerns about it being closed). Which proceedings will take place in the Las Vegas facility, assuming the LA is docketed?
- Schedule for licensing proceedings. When will preconference hearings on petitions/contentions begin?
- How will delays in releasing the final EPA radiation standard for Yucca Mountain impact NRC's review of the LA?
- What does NRC consider the license application – the physical document filed by DOE on June 3rd only, or does it include all documents incorporated by reference?
- NRC staff communication with DOE and third parties (congressional offices, interest groups, NEI, other lobbyists, etc).
- Has NRC considered the proximity of the docketing decision to the presidential election? Does staff have the authority to decide when to make its docketing decision?
- What assumptions is the Commission making (with respect to its budget, number of contentions it will likely review, DOE's outstanding documents/facility designs, etc.) when it says that the LA review can be completed within 4 years?
