The purpose of this letter is to provide updated schedule information for the response to Request for Additional Information (RAI) 200. RAI 200 addresses the Quality Assurance Program Description (QAPD), as discussed in Section 17.5 of the Final Safety Analysis Report (FSAR), as submitted in Part 2 of the Calvert Cliffs Nuclear Power Plant (CCNPP) Unit 3 Combined License Application (COLA), Revision 6.

The referenced letter anticipated that the response to RAI 200, Question 17.5-6 would be provided by June 18, 2010. The submittal date was based on staff review and endorsement of NEI 06-14, Revision 8 to support revision of the UniStar Nuclear Energy QAPD. It is our understanding that the staff has not yet completed its review NEI 06-14, Revision 8, and that the review is likely to continue over the next few weeks. Therefore, our response to RAI 200, Question 17.5-6, including a revised QAPD, or an updated schedule for providing this information, will be provided to the NRC by July 30, 2010.
