Please allow this letter to serve as a response to your request for additional information concerning an amendment request to list me as the Radiation Safety Officer for Bloomington Hospital. I will answer your requests for additional information in the order that they were asked in your fax dated June 9, 2010.

I do currently serve as a Radiation Safety Officer on a license authorizing materials licensed under 10 CFR 35.400. I am the Radiation Safety Officer for Saint Joseph Regional Medical Center, license number 13-02650-02.

In regards to my availability:

- a. I will physically be at Bloomington Hospital one day per calendar quarter. If the need arises, I will be at the hospital more frequently.
- b. My response to an emergency at Bloomington Hospital will be nearly instantaneous via phone communication. I carry both a cellular telephone and a pager at all times, the numbers to which are available to the staff of the hospital.
- c. I currently serve as the Radiation Safety Officer for six USNRC radioactive materials licensees, not including Bloomington Hospital. I do not currently serve as a Radiation Safety Officer on any Agreement State materials licenses. My other commitments will not impact my duties as the RSO for Bloomington Hospital as none of them require significant amounts of hours per week.
- d. My serving as RSO at other facilities will not adversely impact my ability to serve as the RSO for Bloomington Hospital because the position of RSO at Bloomington Hospital does not require full time attention. I am available 24 hours a day via phone in case of emergency.
- e. I will be physically present at Bloomington Hospital one day per calendar quarter. I will am available via phone 24 hours per day.
