The U.S. Nuclear Regulatory Commission (NRC) has received your letter SPM-10-010 dated March 12, 2010, which submitted revisions to Chapters 1 and 4 and Appendix A of the Radiological Contingency and Emergency Plan. In a separate but related action, we have received your letter SPM-10-015 which submitted revisions to the Table of Contents, Chapter 3, and Appendix B of the Plan.
