This letter submits information revising Part 8 of the North Anna Combined License Application for NRC review. 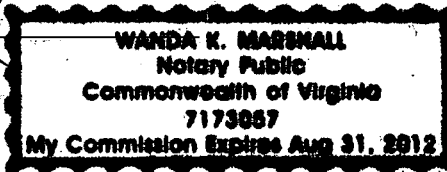
