This letter submits information revising Part 8 of the North Anna Combined License Application for NRC review. Enclosure 1 contains Dominion's Combined Operating License Application (COLA) Security Plan, Training and Qualification Plan, Safeguards Contingency Plan, and Independent Spent Fuel Storage Installation Security Program, Revision 2 (Physical Security Plan). Enclosure 2 contains the Evaluation of CAS/SAS Design for No Single Act, Revision 2 (CAS/SAS Report). Enclosure 3 contains the Supplement to US-APWR High Assurance Evaluation Assessment; and Enclosure 4 contains the Supplement to US-APWR Design Certification Physical Security Element Review.

In parallel, revisions to the North Anna Unit 3 COLA designated Submissions 6 and 7, and the Loss of Large Area Report and a revision to the Cyber Security Plan, are being submitted by two separate letters (Letter Serial Nos. NA3-10-011 and NA3-10-007, respectively).

With regard to the Physical Security Plan (PSP) submitted by this letter, the enclosed Revision 2 replaces Revision 1, submitted March 31, 2009. PSP Revision 2 incorporates Revision 6 (April 2009) to NEI 03-12 and Revision 8 to Dominion's approved operating fleet security plan. It also incorporates the responses to the RAIs resulting from NRC's review of PSP, Revision 1. A summary of the changes is provided with the enclosed PSP.



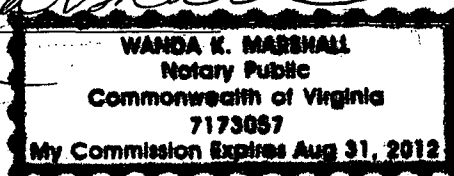
