Under the Freedom of Information Act, I am requesting a point of contacts within your site fitness facility and/or Environmental Health & Safety management designated to review and evaluate your buildings policies on environmental, health and safety products. Our products are Robotic Shower Sanitizing Systems and it would be mounted inside facility communal shower stalls and will prevent the spread of shower related water borne pathogens by spray-washing surfaces with water, cleaner, and sanitizer.
