SUMMARY

We have reviewed your letter dated March 23, 2010, requesting an amendment to your byproduct materials license. As per the telephone discussion on June 14, 2010, between you and I, please submit additional information as follows:

1. We now require a total possession limit for each radionuclide requested, as well as providing the "per source" activity you need, which should match the Sealed Source and Device Registry certificate procured by the vendor. Please provide this information and it is acceptable to request more sealed sources than you may actually need immediately, to allow for some growth, so long as the request is reasonable and realistic.
2. We now require that the proposed Radiation Safety Officer (RSO) accepts the RSO position and that they understand the duties and responsibilities. Please provide a written, signed and dated statement that stipulates your proposed RSO accepts the RSO position and understands the duties and responsibilities associated with the position.
3. You will not be able to change and name your RSO internally, as Condition No. 11.C currently allows; NRC must do that for you via the amendment process. When we complete this amendment we will be deleting Condition No. 11.C.
4. For future reference only, please include the name and qualifications of your proposed RSO and a written, signed and dated statement that stipulates your proposed RSO accepts the RSO position and understands the duties and responsibilities associated with the position. Each proposed RSO must be qualified in accordance with the guidance in NUREG 1556, Vol. 1, Section 8.7, Item 7: "Individual(s) Responsible for Radiation Safety Program and Their Training and Experience."

5. We will also be changing Condition No. 12. F and adding Condition No. 12.H to your materials byproduct license. These changes should enhance your awareness of regulatory requirements and the radiation safety program elements in your license.

Please provide the information requested in writing, appropriately dated and signed by a senior management official, and address it to my attention as "additional information to control number 318963" in order to facilitate proper handling in our office. We will then continue our review.

We will be unable to continue processing your request until we receive this information.


