Marissa - just passing along a 'heads up' from my fire guys, that ACRS is getting interested in 'hot short' issues at fuel cycle facilities. These issues at NPPs arise when postulated fires cause electrical cable insulation to melt and wire-to-wire contacts causes mal-operation of plant equipment. It's been a tough issue to resolve for NPPs because of the need to determine what cables are laid in each cable tray. Lots more details are available if you need to go there.
