SUBJECT: IRIGARAY AND CHRISTENSEN RANCH PROJECT, CAMPBELL AND JOHNSON COUNTIES, WYOMING, SOURCE MATERIALS LICENSE SUA-1341, AMENDMENT NO. 17 – URANIUM ONE AMERICAS, INC., LICENSE AMENDMENT REQUEST TO CHANGE THE LICENSEE NAME FROM COGEMA MINING, INC. TO URANIUM ONE USA, INC. (TAC NO. J00612)

Dear Ms. Wichers:

By letter dated January 27, 2010, Cogema Mining, Inc. and its parent company, Uranium One Americas, Inc., submitted a request to the U.S. Nuclear Regulatory Commission (NRC) to amend Source Materials License SUA-1341 to change the name of the facility on the license from Cogema Mining, Inc. to Uranium One USA, Inc. (NRC Agencywide Documents Access and Management System [ADAMS] ML100351154), to reflect the change of control that occurred on January 25, 2010. Uranium One Americas, Inc. supplemented this request in a letter to NRC dated February 17, 2010, and provided documentation supporting the name change, including a copy of Amendment Number 1 to the Bank of Montreal Irrevocable Letter of Credit, a copy of the Wyoming Secretary of State certification of the name change, a copy of an "Application for Amended Certificate of Authority," and a copy of the Delaware Secretary of State certification of the name change (ADAMS ML100491500). NRC accepted the amendment request for review on February 25, 2010. NRC requested additional information related to the amendment request on April 5, 2010. On May 10, 2010, Uranium One Americas, Inc. responded to the request for additional information (ADAMS ML101410740).

The amendment request is approved and the name on the NRC License SUA-1341 (enclosure 1) has been changed to Uranium One USA, Inc. The basis for NRC approval of the name change is provided in the Safety Evaluation Report (enclosure 2).

This licensing action meets the categorical exclusion provision in 10 CFR Part 51.22(c)(11), as this amendment is an administrative action in that: (i) there is no significant change in the types or significant increase in the amounts of any effluents that may be released offsite; (ii) there is no significant increase in individual or cumulative occupational radiation exposure; (iii) there is no significant construction impact; and (iv) there is no significant increase in the potential for, or consequences from, radiological accidents. Therefore, this amendment does not require either an environmental assessment or an environmental impact statement.
