Desc: I would like all records regarding the expenses associated with NRC R-II's recently completed move to new space in the Marquis One Tower at 245 Peachtree Center Ave. N.E. Atlanta, GA. I seek rental fees per square foot and the number of square feet rented by NRC in the new building. I also seek itemized expenses for new furniture for individual employee offices (per office and number of offices), and executive offices (Division Director and above) (per office and number of offices), general conference rooms (per conference room and number of conference rooms), the executive conference room, and the emergency response center. I also seek itemized expenses for new information technology equipment. The costs for space buildout is also sought. I would also like information about parking spaces paid for by the NRC for use by official Agency vehicles as well as any that might be paid for by NRC for use by NRC employees. Having been responsible for the previous move by NRC R-!

Il to space in the Federal Building I wish to assure, as a private citizen, that the tax payers' money was as wisely spent for this move as it was for the move for which I was responsible.

Waiver\_Purpose: As a citizen and taxpayer, I want to assure that NRC managers have been responsible in the expenditure of public funds.

Waiver\_ExtentToExtractAnalyze: I wish to compare itemized expenses for the subject move with the expenses incurred in the prior move. I am not requesting records for the prior move- I have sufficient notes regarding same.

Waiver\_SpecificActivityQuals: Having been the prior Director of Resource Management and Administration for R-II responsible for the earlier move, I am quite knowledgeable regarding the nature of expenses associated with the movement of a regional office from one building to another. I think that my ability to review the expenses associated with the most recent move will be in conformance with the concept of Open Government espoused by the NRC. In addition, I am in an unusually good position to understand the nature of the expenditures of public funds and to explain such data in a manner that will contribute to public understanding.

Waiver\_ImpactPublicUnderstanding: Currently the vast majority of the general public is not even aware that the NRC Region II office moved, nevertheless that taxpayers' money was used to pay for the move. Taxpayers have no clue regarding the amount of money required nor the kinds of things for which such money is spent. Any analysis of this data outside the boundaries of NRC will enlighten the citizenry as if turning on a 100 watt light bulb in a dark room.
