DPR-5, DPR-26, and DPR-64. The proposed change would have modified the Facility Operating License (FOL) Physical Protection license condition pertaining to implementation of Entergy's Cyber Security plan in accordance with the approved schedule and maintaining in effect all provisions of the Commission-approved Cyber Security plan.
