

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.) The purpose of this modification is to accept the the revised cost proposal dated 5/26/2010 for the subject task order. The revised cost proposal includes a Sr. Quality Assurance Manager that was excluded from the original cost proposal dated 3/5/2010. The contractor submitted an invoice in the amount of \$5202.95, of which \$1,283.91 was suspended due to the contractor's exclusion of the Sr. Quality Assurance Manager in its original cost proposal. The inclusion of the Sr. Quality Assurance Manager does not result in additional cost to the government and has no impact on the task order ceiling, as the revised cost proposal total amount is the same as the original cost proposal, \$130,786.07. There are sufficient funds on the task order, in the amount of \$36,544.63, to pay the suspended amount of \$1,283.91. As a result, no additional obligations are required.
