ROBINSON STEAM ELECTRIC PLANT, UNIT NO. 2; AND SHEARON HARRIS NUCLEAR POWER PLANT, UNIT NO. 1 — WITHDRAWAL OF AN AMENDMENT REQUEST FOR APPROVAL OF THE CYBER SECURITY PLAN (TAC NOS. ME2664, ME2665, ME2666, ME2746, AND ME2796)

Gentlemen:

By letters dated November 18, 19, and 23, 2009 (Agencywide Documents Access and Management System (ADAMS) Accession Nos. ML093410254, ML093270227, ML093340350, and ML093290248), the Carolina Power & Light Company, now doing business as Progress Energy Carolinas, Inc., and the Florida Power Corporation, now doing business as Progress Energy Florida, Inc. (the licensees), applied for license amendments for the Brunswick Steam Electric Plant, Units 1 and 2, the Crystal River 3 Nuclear Generating Plant, the H.B. Robinson Steam Electric Plant, Unit No. 2, and the Shearon Harris Nuclear Power Plant, Unit 1 (Facility Operating License Nos. DPR-71, DPR-62, DPR-72, DPR-23, and NPF-63, respectively).

The license amendment requests (LARs) included the Cyber Security Plan, proposed changes to the (Renewed) Facility Operating License, and a proposed Cyber Security Plan Implementation Schedule for each facility. The proposed Cyber Security Plans were submitted in accordance with Title 10 of the *Code of Federal Regulations*, Section 73.54, "Protection of digital computer and communication systems and networks."


