14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to: (1) increase the level of effort for ad-hoc security analyses, developing procedures, and working with staff to streamline and recommend improvements to information security processes; (2) add funding in the amount of \$160,341.00; and (3) increase the task order ceiling.

As a result of increasing the level of effort, the total obligated amount of this task order is increased by \$160,341.00 from \$265,156.39 to \$425,497.39. The ceiling increased by \$135,592.80 from \$289,904.59 to \$425,497.39. The remain available ceiling is \$0.00. The Contractor cannot exceed the currently obligate amount. If the Contractor exceeds the stated amount, the Contractor does so at it's own risk.

All other terms and conditions remain unchanged.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
