Dear Ms. Wheeler;

I have been requested to respond to your e-mail to Perry Buckburg of the NRC staff.

The Licensing Board has indicated that the hearing will be held during the weeks of April 7 or April 14, 2008. An exact date has not yet been chosen. A venue for the hearing has not been selected. Prior the hearing, the Licensing Board will issue an Order specifying the date and place of the hearing.

Regarding your desire to speak at the hearing, this is an adjudicatory hearing. Therefore, the practice is that only the admitted parties, their representatives and their witnesses be permitted to participate in the hearing.
