Ron,

On July 6, 2010, well number P-2469 failed a routine 5-year mechanical integrity test. The failure has been determined to be in a casing joint at the 60-foot level. The Chadron Formation static water level in this area is approximately 240 feet below the failed joint. As this well is a producer, it is unlikely that Chadron Formation water has reached the depth of the failed joint. Routine biweekly sampling results from nearby shallow monitor wells do not indicate a loss of solutions from the failed joint.
