The purpose of this modification is to provide incremental funding in the amount of \$50,000.00, thereby increasing the obligated amount from \$555,000.00 to \$605,000.00.

Accordingly, the following contract is modified as follows:

(3) Subsection B.2(b) – "Consideration and Obligations – Delivery Orders," is revised as follows:

(b) The amount presently obligated to this contract is **\$605,000.00**. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.
