The purpose of this modification is to provide incremental funding in the amount of \$317.00, thereby increasing total obligations from \$34,625 to \$34,942.

Accordingly the following changes are hereby made:

Paragraphs (c) of Section A.1 CONSIDERATION AND OBLIGATION--COT PLUS FIXED FEE (JUN. 1988) ALTERNATE I (JUN 1991) are hereby deleted and replaced with the following:

"(c) The amount currently obligated by the Government with respect to this contract is **\$34,942.00**, of which the sum of **\$32,388** represents the estimated reimbursable costs, and of which **\$2,554** represents the fixed fee."
