Pursuant to Chapter 11 of the Bankruptcy Code* (the "**Plan**") and (b) the *Disclosure Statement Regarding the Joint Plan of Reorganization of Tronox Incorporated, et al. Pursuant to Chapter 11 of the Bankruptcy Code* (the "**Disclosure Statement**") with the United States Bankruptcy Court for the Southern District of New York (the "**Bankruptcy Court**"). 
