Dear Mr. Pacilio:

The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2010-011) on December 7, 2009, to determine whether employees at the Limerick Generating Station discriminated against a Radiation Protection Technician (RPT) as a result of raising safety concerns. Based on information developed during an abbreviated investigation, the NRC concluded that there was insufficient evidence to conclude that the RPT was subject to discrimination by Limerick employees as a result of raising safety concerns. Specifically, the NRC's conclusion was based on the RPT no longer wishing to pursue an investigation and the limited amount of investigatory information which had been collected at that time.

In addition, the NRC also noted that a DOL Administrative Law Judge issued a Recommended Decision and Order Approving Settlement Agreement and Order of Dismissal with Prejudice. In this documentation, a Joint Motion for Approval of Settlement Agreement, Dismissal with Prejudice, and Confidential Treatment of Settlement Agreement was approved. Since no appeals were filed by either party within 10 days, this Recommended Decision and Order automatically became the Final Order.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA. Requests under the FOIA should be made in accordance with 10 CFR 9.23, Requests for Records, a copy of which is enclosed for your information.
