Response to Regulatory Information Summary 2010-08, "Preparation and Scheduling of Operator Licensing Examinations"

On June 28, 2010, the NRC issued Regulatory Issue Summary (RIS) 2010-08. RIS 2010-08 requests that each licensee provide an update of operator licensing examination information for calendar years 2011 through 2014.

 Examine the weeks of November 18 and 25, 2013
