Nuclear Medical Resource Professionals User Group Meeting

On July 12, 2010, NRR staff attended a meeting of the Nuclear Medical Resource Professionals User Group and presented information on recent enforcement actions related to licensed operator medical issues and review of licensee medical certifications using NRC Form 396. The staff also participated in a meeting of the committee working on a revision of ANSI/ANS-3.4 which covers medical certification and monitoring of licensed operators.

Public Meeting with the Licensee for Millstone

On July 13, 2010, NRR staff held a public meeting with the licensee for Millstone to discuss the licensee's planned responses to an NRC staff request for additional information regarding Generic Letter 2004-02, Pressurized Water Reactor Sump Performance.

U.S. Department of Energy (DOE) Blue Ribbon Commission on America's Nuclear Future
Meeting in Washington, DC

On July 7, 2010, NMSS staff observed a public subcommittee meeting of the DOE Blue Ribbon Commission on America's Nuclear Future. The Disposal Subcommittee met in Washington, DC and discussed various topics related to options for disposal of spent nuclear fuel and high-level waste. Presentations to the subcommittee included contrasting perspectives on the Waste Isolation Pilot Plant and Yucca Mountain projects from multiple stakeholder groups, and insights from several international programs. Many of the presenters stressed the importance of stakeholder participation throughout the facility development process. Web Streaming Services

On July 8, 2010, as a result of a competitive small business set-aside procurement, a firm fixed-price requirements contract (NRC-10-10-370) was awarded to Granicus, Inc. in San Francisco, California. The objective of this procurement is to provide the NRC with Web streaming services to broadcast NRC meetings over the internet and to provide access to those meetings via a Webcast Web page. The period of performance is July 21, 2010, through February 19, 2011, with two 1-year option periods. The total cost is \$463,858.94 inclusive of all options.

Mechanical Codes and Standards Training Course

On July 9, 2010, as a result of a full and open competition, a hybrid type contract (firm fixed price with cost reimbursement items) (NRC-38-10-699) was awarded to Advanced Systems Technology and Management, Inc. in Vienna, Virginia. The objective of this procurement is to develop training materials and provide instructional services for a course titled, "Mechanical Codes and Standards." The period of performance is July 12, 2010, through July 11, 2011, with four 1-year option periods. The total cost is \$431,757.19 inclusive of all options.
