

 The purpose of this modification is to increase the obligated amount by \$120,000 from \$759,000 to \$879,000. According paragraph (c) of Section B.3 of the contract entitled: "Consideration and Obligation Cost Plus Fixed Fee (JUN 1988) Alternate I (JUN 1991) is revised to read as follows:
 "(c) The amount currently obligated by the government with respect to this contract is \$879,000, of which the sum of \$818,735 represents the estimated reimbursable costs and of which \$60,265 represents the fixed fee."
