The staff has performed a detailed review of ESBWR Chapter 9 and has prepared the Advanced FSE (available under the Agencywide Documents Access and Management System (ADAMS) Accession Number ML102080698). The Advanced FSE is being provided to support the upcoming meeting of the Advisory Committee on Reactor Safeguards (ACRS) ESBWR Design-Centered Subcommittee, scheduled to be held on September 23-24, 2010. The ACRS Full Committee meeting will be held on October 7, 2010. The staff concludes that the Advanced FSE does not contain any information for which exemption from public disclosure has been sought or approved. However, the NRC will withhold the Advanced FSE from public disclosure for ten calendar days to allow GEH the opportunity to verify the staff's conclusion that the Advanced FSE contains no such exempt information or any factual errors. Therefore, the staff requests that the ACRS withhold the Advanced FSE from public disclosure until the information has been released publicly in ADAMS.
