 The purpose of this modification is to: (1) Exercise and fully fund **OPTION PERIOD 5**, thereby increasing the ceiling and obligated amounts under the contract by \$89,541.84, from \$244,145.48 to \$333,687.32, and extending the duration of the contract period to expire on September 30, 2011. Accordingly, the contract is modified as follows:
