This letter informs the Nuclear Regulatory Commission of American Electric Power's (AEP's) intent to evaluate the potential submission of an application for a combined construction permit and operating license (COL) in accordance with 10 CFR 52.

AEP plans to conduct the evaluation for the potential submission of a COL application in 2008. [If the decision is made to proceed with the preparation and submission of the COL application, AEP anticipates that the application would be submitted in the 2010–2011 timeframe.]

AEP considers the information within brackets in this letter as meeting the confidentiality provisions of 10 CFR § 2.390(b)(4)(v) and, is therefore requesting that the information be withheld from public disclosure. - 1. I am Chief Nuclear Officer and Senior Vice President of American Electric Power (AEP), and as such, have the responsibility of reviewing the proprietary information sought to be withheld from public disclosure in connection with AEP's letter AEP:NRC:8002, dated April 15, 2008, and am authorized to apply for its withholding on behalf of AEP.
- 2. I am making this affidavit in conformance with the provisions of 10 CFR 2.390 of the regulations of the Nuclear Regulatory Commission (NRC) and in conjunction with AEP's application for withholding, which accompanies this affidavit.
- 3. I have knowledge of the criteria used by AEP in designating information as proprietary or confidential.
- 4. Pursuant to the provisions of 10 CFR 2.390(b)(4), the following is being furnished for consideration by the NRC in determining whether the information sought to be withheld from public disclosure should be withheld.
 - (i) The information sought to be withheld from public disclosure has been held in confidence by AEP.
 - (ii) The information is of a type that would customarily be held in confidence by AEP. The information is sensitive business information and its disclosure would likely cause substantial harm to the competitive position of AEP.
 - (iii) The information is transmitted to the NRC in confidence, and under the provision of 10 CFR 2.390, it is to be received in confidence by the NRC.
 - (iv) The information sought to be protected is not available in public sources to the best of my knowledge and belief.
 - (v) The proprietary information sought to be withheld is contained in letter AEP:NRC:8002, "Intent to Evaluate the Potential Submission of Combined Construction Permit and Operating License," dated April 15, 2008, transmitting this attachment.

Letter AEP:NRC:8002 informs the NRC of the anticipated time frame in which AEP would apply for a combined construction permit and operating license if it elects to do so. Public disclosure of this information is likely to cause harm to AEP because it would likely cause substantial harm to the competitive position of AEP.
