Enclosed is Amendment No. 5 to your NRC Material License No. 24-32459-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

Please note, based upon the close-out survey results in the letters dated April 14, 2010, and July 26, 2010, we have authorized the release of the nuclear medicine facility at 1035 Karsch Blvd., Suite A, Farmington, Missouri, for unrestricted use.

NRC's Regulatory Issue Summary (RIS) 2005 31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.
