Supplement to Response to NRC Generic Letter 2007-01: Inaccessible or Underground Power Cable Failures that Disable Accident Mitigation Systems or Cause Plant Transients (TAC Nos. MD4367 and MD4368)

References: 1. Letter from Nuclear Management Company, LLC (NMC) to NRC "Response to NRC Generic Letter 2007-01: Inaccessible or Underground Power Cable Failures that Disable Accident Mitigation Systems or Cause Plant Transients", dated May 8, 2007, ADAMS Accession Number ML071290142.

In reference 1, NMC^{*} submitted the required response to Generic Letter (GL) 2007-01 for the Prairie Island Nuclear Generating Plant (PINGP), Units 1 and 2. In recent reviews of this response, two issues were identified for which supplemental information is provided:

- GL 2007-01 requested "a history of inaccessible or underground power cable failures". The NMC response included Cable 24402-2 for the 22 Circulating Water Pump as a cable that failed. In actuality, the cable continuously provided service and did not fail. However, a defect was identified during maintenance testing which was repaired to preclude failure.
- The response stated, "At PINGP, power cables are routinely tested under preventive maintenance procedures for their loads." As of the date of Reference PINGP staff was not routinely testing bus feeder cables, including cables that supply offsite power sources to the 4 kV safeguards buses and the motor control

centers (MCCs 1AB1 and 1AB2) which supply control power to safety related equipment.
