We are requesting you to conduct a proprietary review of our draft Safety Evaluation Report (SER) for the AREVA Enrichment Services, LLC Eagle Rock Enrichment Facility proposed to be located in Bonneville County, Idaho. Please provide us with the written results of your proprietary review by September 15, 2010. In the enclosed SER, Appendix A has been redacted of the export controlled information and Appendix G is not included because it contains extensive export controlled information and is not practical to provide a redacted version. Unless your proprietary review determines otherwise, Appendices A through H of the SER will not be subject to public disclosure as they contain security-related, proprietary, or export controlled information and will be withheld in accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 2.390. The balance of the SER will be withheld from public disclosure until your proprietary review is complete.
