By letter dated November 20, 2009 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML093350548), you applied for an amendment to the D. C. Cook Nuclear Plant, Units 1 and 2, Operating License Nos. DPR-58 and DPR-74 in accordance with 10 CFR 50.90 and 10 CFR 73.54, "Protection of digital computer and communication systems and networks." The proposed amendment would modify DPR-58 and DPR-74 to impose requirements regarding the computer cyber security program.
