### RAI 245

### Question 13.03-41

In RAI 13.03-13(D), staff requested the names, locations and a discussion of the services each "other Licensee and contracted laboratory" will provide and include a summary in the CCNPP Unit 3 Emergency Plan. The applicant provided information regarding the location, availability and capabilities of onsite and offsite laboratories and stated that Section B.8.d will be revised to include that information. If the "Laboratory Services Section" is an independent laboratory that is not part of the applicant's organization, provide a Letter of Agreement with the "Laboratory Services Section", or explain why one is not necessary.

### Response

The "Laboratory Services Section" is an organization within the technical services department of Constellation Power, Inc.

As described in our response to RAI 13.03-7(C)<sup>1</sup>, COLA Part 10, Table 2.3-1, was supplemented with an ITAAC to acquire the final and complete Letters of Agreement (LOA) developed between Federal, State, and local agencies and other support organizations having an emergency response role within the Emergency Planning Zones (as defined in Appendix 3 of the Emergency Plan). The Letters of Agreement are required to be submitted to the NRC no less than 180 days prior to fuel load.

The list of Letters of Agreement contained in COLA Part 5, Emergency Plan, Part III, Appendix 3, is being revised to include the Letter of Agreement between Constellation Power, Inc. and CCNPP Unit 3. The letter of agreement will include the use of the Fort Smallwood Road Shops Complex for provision of the services described in our response to RAI 13.03-13(D).<sup>1</sup>
