Petitioner's Consent Motion for Leave to Include Five Non-Record <u>Documents in the Supplemental Appendix</u>

Pursuant to Circuit Rule 27, Petitioner Shieldalloy Metallurgical Corporation respectfully moves this Court for permission to include in the Supplemental Appendix approved by the Court on April 28, 2010 five additional non-record documents cited in Petitioner's Reply Brief. Respondents (the U.S. Nuclear Regulatory Commission and United States of America) consent to the granting of this motion.

- 4. This is a deferred-appendix case that is still at the initial briefing stage.

 Appendices and final briefs have not yet been filed. It would not be burdensome to include five additional documents in the Supplemental Appendix that this Court has already approved.
