CONFIRMATION OF INITIAL OPERATOR LICENSE EXAMINATION

Dear Mr. Davis:

In response to your letter dated March 10, 2010 (NRC-10-0018), you requested dates for initial operator licensing examinations in 2015 and 2016.

We have scheduled an examination for February 23 and March 2, 2015, with an onsite validation date of February 2, 2015. Additionally, we have scheduled an examination for September 12 and 19, 2016, with an onsite validation date of August 22, 2016.

In the unlikely event that we are unable to support the examination during the scheduled weeks, we will inform you immediately upon discovery of such conditions and make arrangements to administer the examination at a mutually acceptable date.

We understand that your staff will develop the examinations. Please inform us at your earliest opportunity if you discover you need to change the scheduled examination date.

A supplementary letter will be sent to the training department approximately 120 days prior to the examination informing the training manager of the chief examiner's name. The letter will also outline examination security expectations, list the materials required by the NRC to review and conduct the examination, reconfirm the examination date, and reconfirm the number of candidates you have in the training program.
