
As you know, the State of New Jersey became an Agreement State on September 30, 2009. On December 17, 2009, NJDEP contacted Rutgers University (Rutgers) to inform Rutgers of the need to issue new financial assurance documents with the State of New Jersey Department of Environmental Protection (NJDEP) as the beneficiary.
