14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to provide incremental funding in the amount of \$161,000.00, thereby increasing the total obligations from \$2,375,173.58 to \$2,536,173.58. Accordingly the contract is modified as follows:

Refer to Section B.3 entitled "CONSIDERATION AND OBLIGATION - COST PLUS FIXED FEE (JUNE 1988)" paragraph (g) is hereby deleted in its entirety and replaced with the following:

" (g) The amount currently obligated by the Government with respect to this contract is \$2,536,173.58, of which the sum of \$2,360,655.99 represent the estimated reimbursable costs, and of which \$175,517.59 represents the fixed fee."

All other terms and conditions remain the same including the contract ceiling of \$3,524,191.00.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
