The purpose of this letter to respond to the request for additional information (RAI) identified in NRC correspondence to PPL Bell Bend, LLC (PPL) for RAI No. 93 (Reference 1). This RAI addresses Regional Climatology as discussed in Chapter 2 of the Final Safety Analysis Report (FSAR) and submitted in Part 2 of the Bell Bend Nuclear Power Plant (BBNPP) Combined License Application (COLA).

References 1, 2 and 3 identified that additional time would be required to provide a response to RAI Question 02.03.01-2 as the development of the BBNPP response is dependent on an RAI response for the U.S. EPR FSAR. The schedule for the U.S. EPR FSAR RAI question response has been revised, resulting in the re-scheduling of the BBNPP FSAR RAI Question 02.03.01-2 response submittal beyond the August 13, 2010 date (References 3 and 4). The schedule for this BBNPP RAI No. 93 Question 02.03.01-2 response submittal is November 19, 2010.

The only new regulatory commitment in this letter is to submit the RAI No. 93 Question 02.03.01-2 response by the identified date.
