By letter dated July 2, 2009, SCE&G submitted in Reference 1, COLA Part 14, Loss of Large Areas of the Plant due to Explosions or Fire – Mitigative Strategies Description (MSD) and Plan as required by 10 CFR 52.80(d). During the review of the SCE&G and the R-COLA MSD, the staff requested additional information pertaining to the R-COLA. During subsequent conversation, in Reference 2, the staff requested similar information for the VCSNS MSD. This letter endorses standard material submitted by the R-COLA which is applicable to the VCSNS MSD submittal and also provides further information for the item not endorsed, R-COLA RAI 19-91. In addition, R-COLA RAI 19-102 has not been included but will be addressed in a future response.
