

The purpose of this modification is to (1) extend the Period of Performance from 07/14/2008 – 07/13/2010 to 07/14/2008 thru 09/30/2011 and, (2) reduce the scope by deleting Tasks 1, 2, and 3 as seen in the attached revised Statement of Work. Accordingly, the subject task order is hereby modified as follows:

Paragraph 3, page 2 of 2 under the base task order 5, is hereby deleted in its entirety and replaced with the following:

"The amount obligated by the Government with respect to this task order is \$58,612.00, of which \$55,874.33 represents the estimated reimbursable costs, and the amount of \$2,737.67 represents the fixed fee."
